Soos Creek's Water & Sewer Rates - 2022

Our water and sewer rates are among the lowest in the region

The Board of Commissioners establishes utility rates on an annual basis. The decision is made after District staff proposes and the Board approves an expenditure budget for the upcoming year. The District held a public hearing to obtain comments on the proposed 2022 water and sewer rates. On November 17, 2021, the Soos Creek Board of Commissioners approved a 3% increase in the monthly base charges and volume charges for water and 5.9% overall rate increase for sewer rates. Please note that King County's sewage treatment rate is set by the King County Council, not by Soos Creek Water & Sewer District. The increases will be effective with the February 28, 2022 billing cycle.

WATER Rates

The District will increase water rates for 2022 to fund higher operating costs. Below is an outline of the current rates and the 2022 rates.

SEWER Rates

The sewer bills sent to Soos Creek customers itemize the charges for Soos Creek's sewer rate and King County's Sewage Treatment charges. The District's portion of the bill is for the maintenance of our system that collects the sewage from your existing structure (house, business, or school) and conveys it to King County's system and ultimately to the Renton Treatment Plant.

The King County Sewage Treatment charge shown on the Soos Creek sewer customer's bill reflects King County's capital and operating costs for treatment and disposal of sewage. Below is an outline of the current sewer rates and the 2022 rates.
