SOOS CREEK EMPLOYEES ARE HIGHLY SATISFIED, MOTIVATED, AND ENGAGED

The District's employees recently completed a confidential Employees Opinion Survey conducted by Archbright (independent consultant), and the results were outstanding. Average favorability across all questions was 93% versus the national average of 80%. There were 10 measurement factors including: Executive Leadership Effectiveness, Supervisory Leadership Effectiveness, Communication, Pay, Benefits, Operational Effectiveness, Organizational Effectiveness, Employee Development and Recognition, Work Life Satisfaction, and Employee Commitment.

The survey also had a component to measure employee engagement: "A heightened emotional and intellectual connection that an employee has for his/her job, organization, manager, or co-workers that, in turn, influences him/her to apply additional discretionary effort to his/her work." We are proud to announce that the District has <u>0%</u> (zero) disengaged Soos Creek employees versus the national average of 18% disengaged.

2018 WATER AND SEWER RATES

The Board of Commissioners establishes utility rates on an annual basis. The decision is made after District staff proposes and the Board approves an expenditure budget for the upcoming year. The District held a public hearing to obtain comments on the proposed 2018 water and sewer rates. On December 6, 2017, the Soos Creek Board of Commissioners approved a 2.5% increase in the monthly base charges and volume charges for water and a 2% increase in Soos Creek's portion of the sewer rates. King County's sewage treatment rate is shown as a separate charge on your bill, and will remain \$88.44 in 2018. The increases will be effective with the February 28, 2018 billing cycle.

WATER

The District will increase water rates for 2018 to fund higher operating costs. Below is an outline of the current rates and the 2018 rates.

SEWER

The sewer bills sent to Soos Creek customers itemize the charges for Soos Creek's sewer rate and King County's Sewage Treatment charges. The District's portion of the bill is for the maintenance of our system that collects the sewage from your existing structure (house, business, or school) and conveys it to King County's system and ultimately to the Renton Treatment Plant. Effective with the February 28, 2018 billing cycle, Soos Creek's base rate will be \$36.78 (bimonthly) and the Volume Charge for commercial customers will increase to \$2.45 per 100 cubic feet of water in excess of the first 1,500 cubic feet (bimonthly).

The King County Sewage Treatment charge shown on the Soos Creek sewer customer's bill reflects King County's capital and operating costs for treatment and disposal of sewage. King County's sewer rate will remain \$88.44 (bimonthly) and King County's Volume Charge for commercial customers will remain at \$5.90 per 100 cubic feet of water in excess of the first 1,500 cubic feet. <u>STREET LIGHTS</u>

Street light rates will be unchanged at \$5.30 bimonthly.
